ORDER

WHEREAS, Kamla Bhubaneswar B.Ed College, Plot No-1410, 1411, 1412, Vill./Po. Chandour, Tehsil/Taluka-Bhagwanpur, Town/City-Teghra, Dist-Begusarai, Bihar-851133 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.24275 dated 25.02.2014 from the academic session 201-2015, followed by revised recognition order vide No.31947 dt.23.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- AND WHEREAS, as per decision of the ERC taken in its 278th meeting held on 16th 18th January, 2020, withdrawal order vide No.62216 dt.01.02.2020 issued to the institution from the academic session 2020-2021.
- AND WHEREAS, the institution preferred 2nd appeal and the Appellate Authority vide order No.89-184/E-164769/2020 Appeal/ 26th Mtg.-2020/ 27th October, 2020/ 95208 dated 3. 27.11.2020 remanded back the case to the ERC with a direction to consider the documents submitted in appeal, to be sent to them by the appellant, and take necessary action as per NCTE Regulation, 2014. The appellant is directed to forward to ERC all the documents submitted in appeal, within 15 days of the issue of appeal order.
- AND WHEREAS, institution also filed W.P.(C) 10074/2020 & CM APPLs.32065-66/ 2020 in the Hon'ble High Court of Delhi at New Delhi. The Hon'ble Court disposed of the matter on 09.12.2020. The ERC in its 288th meeting held on 29th January, 2021 considered the order passed by the Hon'ble High Court of Patna and decided to issue a letter to the institution with a direction to replace the faculty and to appoint a qualified faculty at Sl. No.6 and to submit the same with duly approved by the Registrar of the concerned affiliating body within 30 days from the date of issue of letter.
- AND WHEREAS, institution submitted representation dated 13.02.2021 received on 13.02.2021 through E-mail. The ERC in its 289th meeting held on 15th February, 2021 considered the matter and decided as under:-

Restoration of recognition Order for B.Ed. course with an annual intake of 100 (Two units) be issued.

NOW THEREFORE, withdrawal order dated 01.02.2020 issued to the institution viz. Kamla Bhubaneswar B.Ed College, Plot No-1410, 1411, 1412, Vill./Po. Chandour, Tehsil/Taluka-Bhagwanpur, Town/City-Teghra, Dist-Begusarai, Bihar-851133 for B.Ed. course is hereby restored permitting the total annual intake of 100 (two basic units). Contd...2
