ORDER

WHEREAS, Kamla Bhubaneswar Educational Trust, Plot No. 441, Street/Road- Kanti Factory Road, Vill- Mahatma Gandhi Nagar, Po- Bahadurpur, Tehsil/Taluka- Patna Sadar, Town/City- Patna, Dist.- Patna, Bihar- 800026 had applied through online dated 30.06.2015 for grant of recognition for D.El.Ed. (Addl. Course) under the institution viz. Kamla Bhubaneswar B.Ed. College, Plot No. 1410, 1411, 1412, Vill/PO- Chandour, Tehsil/Taluka- Bhagwanpur, Town/City- Teghra, Dist.- Begusarai, Bihar-851133 (Code No. ERCAPP4296) of two year duration Under Section 15 of the NCTE Act 1993 and hard copy of the application was received on 30.06.2015 by the ERC office.

2. AND WHEREAS the Eastern Regional Committee in its 202nd meeting held on 18th – 23rd January 2016 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs from time to time, the Committee discussed the matter in detail and observed as under:

As per Clause 7(2)(a) & (b), the application shall be summarily rejected under one or more of the following circumstances:

- (a) Failure to furnish the application fee, as prescribed under rule 9 of the National Council for Teacher Education Rules, 1997 on or before the date of submission of online applications;
- (b) Failure to submit print out the applications made online along with the land documents as required under sub-regulation (4) of Regulation (5) within fifteen days of the submission of the online application.

Taking the above Clauses of the Regulation 2014 into consideration, the Eastern Regional Committee observed as follows:

1. The institution has not submitted land document with hard copy of online application.


In view of the above the Committee decided as under:

The application of the institution is summarily rejected as per clause 7(2)(b) of NCTE Regulation 2014.

3. NOW, THEREFORE, as per the decision of ERC, the application submitted by the applicant for grant of recognition for B.Ed. to the institution viz. Kamla Bhubaneswar B.Ed. College, Plot No. 1410, 1411, 1412, Vill/PO- Chandour, Tehsil/Taluka- Bhagwanpur, Town/City- Teghra, Dist.- Begusarai, Bihar-851133 (Code No. ERCAPP4296) is hereby summarily rejected as per Clause 7(2)(b) of NCTE Regulation 2014.

4. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
